
FUND'S DESCRIPTION

1. The Fund participates of local interest rates levels and USD/MXN exchange rate movements.


2. The Fund takes advantage of currency volatility by using FX Options in order to create an excess return above local interest rates in the long-term.


ASSET CLASS BREAKDOWN¹




